- Fabricate and install one internally illuminated, double-faced monument sign with electronic message center at each of the above listed locations.
- Sign stands approximately 7' tall, spans 9' across, and is 2' wide.
- Base and column shall be all aluminum construction painted acrylic polyurethane custom.
- Address numerals and Station Number copy shall be painted directly onto column/base.
- Main ID cabinet shall be all aluminum construction painted acrylic polyurethane.
 Face shall be aluminum with copy routed out and backed with 3/16" thick white acrylic.
- ID face illumination via white LED modules powered by low voltage.
- Furnish and install 19 mm, double-faced twinpack, fTemperature sensor with cable. Full color WatchFire, Dacktronics or Optec message/graphics display unit with software installed on District supplied computer.
- Communication system via 4G wireless with 5-year cellular data plan.
- Provide software training.

General Specifications:

- Winning bidder will apply for permits and comply with all city/county regulations.
- Aluminum surfaces shall be sanded, primed and sprayed with Matthews acrylic polyurethane finish in a dust free, environmentally controlled paint booth for superior adhesion.
- Fabrication shall be performed by skilled craftsmen.
- Installation and all on-site work shall be performed by licensed journeymen.
